BBQ COOK-OFF

- ☆ Meat needs to be checked by a benefit promoter on Friday October 26, 2007 before cooking begins. If no one has checked it by 6:00 p.m. you may begin cooking.
- ☆ Any and all meat and/or meats that may be entered into judging will be cooked from scratch within the constraints of the event. Pre-cooking, marinating, etc., will not be allowed prior to start of the cook-off as defined by the cook-off promoter.
- ☆ Schedule and rules will be provided when you check in on Friday.
- ☆ All teams must be checked in, and in place by 5:00 p.m. on Oct. 26, 2007 at which time no motorized vehicles, or other objects that might cause harm or injury will not be allowed in cook area except promoter or official security. (to include 4 wheelers, golf carts, scooters, skate boards, in-line skates, bicycles etc.)
- ☆ All entries must be turned in at the designated time.
- ☆ It is the responsibility of the contestant to see that the contest area is kept clean and that the area is cleaned and policed following the contest.
- ☆ Excessive use of alcoholic beverages may be grounds for disqualifications. Under no circumstances are alcoholic beverages to be distributed to the general public by contestants.
- ☆ No animals allowed in cook-off area, with exception to Seeing Eye Dogs
- ☆ IBCA judging rules will apply
- ☆ Promoter and cook-off officials will not be held responsible for accidents, theft, or any mishaps.
- ☆ RV hook-ups are available for an additional \$25 per night charge.
- ☆ Props, trailers, motor home vehicles, tents and any other equipment may not exceed the boundary of the contestant's assigned space without written consent by the promoter.
